## INSTRUCTIONAL INNOVATIONS New Courses Offered

- Economics, Gender, and Social Provisioning (EC445/845): Developed/Taught Spring 2010 and Spring 2012. This course examines important current topics in economics relating to gender. The course examines the significance of gender in household relations, the care economy, international migration, development policies, job segregation and the wage gap, and behavioral economics and the study of gender.
- **Feminist Economics (EC427):** Developed Spring 2007. Senior seminar on feminist thought in economics. This course examines the history of economic ideas and issues from feminist perspectives. Viewing economics as a social practice with concrete historical origins, the course examines the development of feminist thought from Mary Wollstonecraft to the present offering a substantive challenge to the content, scope, and methodology of economics while evaluating the nature of social arrangements surrounding provisioning.
- **Feminist Economics (EC975):** Developed Spring 2005. Doctoral seminar on feminist thought in economics. This course examines the history of economic ideas and issues from feminist perspectives. Viewing economics as a social practice with concrete historical origins, the course examines the development of feminist thought from Mary Wollstonecraft to the present offering a substantive challenge to the content, scope, and methodology of economics while evaluating the nature of social arrangements surrounding provisioning.
- 21st Century Alternatives: Women, Work, and Family in Sweden and the U.S. (EC389) This course provides for a study abroad experience in Stockholm Sweden in which students are able to examine conditions for women and work in one of the most advanced industrial democracies in the world. Special attention is given to occupational segregation, wage inequality, family leave and women's health policies. Students are

encouraged to critically examine public policy and its impact in society on women and work.

## History of Women and Work in the U.S. (EC375 cross-listing in history as HY 375):

Developed Spring 1993. This course examines the transformation in women's role in the U.S. economy from colonial times to the present and the effects of class, race, and changing perceptions of women's role in society. Special attention is given to the role of women in household manufacture, the early factory system, the trade union movement, the Great Depression, the home front during WWII, and the economic emergence of women in the postwar era.

- Conflict and Conflict Resolution (PO261): Developed Spring 1988. Team Taught. This course provides an interdisciplinary approach to the study on war and peace for undergraduate students and is taught off load by the Professors involved.
- The Evolution of Corporate Capitalism, Graduate Seminar in U.S. Economic History (EC975): Developed Spring 1990. This course examines the age of corporate capitalism in the U.S. from the late 19th century to the present and the ways in which various social movements and groups responded to and helped shape the particular character of our corporate capitalist culture.
- New Dimensions of Labor History, Graduate Seminar in U.S. Economic History (EC975)

  Developed Spring 1992. This course explores the ways in which gender, race, and class relations shaped workers' experience in the U.S. in the 19th and the 20th centuries.
- Controversies in the Evolution of the U.S. Economy. Graduate Seminar in U.S. Economic History (EC975) Developed Spring 1997. This course examines the central controversies in the evolution of capitalism in the U.S. beginning with the market revolution of a predominately rural society and concluding with the breakdown of the capital-labor accord of the 1950s.
- 19<sup>th</sup> Century U.S. Economic History (EC457/857 cross-listed as HY457/857): Developed Fall 1987. This course examines the development of the U.S. from an agrarian to an industrial society and the impact of that transformation on people's lives and livelihoods.
- 20<sup>th</sup> Century U.S. Economic History (EC458/858 cross-listed as HY458/858): Developed Spring 1988. This course examines the U.S. economy in the 20th century and focuses on such topics as the continued consolidation of the business enterprise, the Great Depression of the 1930s, and the role of government in managing and coping with the transformation in economic life.
